

**NOTICE OF SCHOOL TRUSTEE ELECTION DEADLINES FOR
DECLARATION OF CANDIDACY**

Horseshoe Bend School District No. 73
Boise County, Idaho

Public Notice is hereby given according to law, and the requisite action of the Board of Trustees of Horseshoe Bend School District No. 73, Boise County, Idaho, that the annual school trustee election will be held on November 5, 2019.

Notice is also provided that:

Candidates interested in filing a declaration of candidacy must file no later than 5:00 p.m. on September 6, 2019.

Each Declaration must bear the name of the candidate, state the term for which declaration of candidacy is made, and bear the signature of not less than five (5) qualified school district electors of the Trustee Zone of which the candidate is resident.

Only those qualified electors residing in Trustee Zone No. Two (2) may declare candidacy for Zone No. Two (2) Trustee position. Only those qualified electors residing in Trustee Zone No. Three (3) may declare candidacy for Zone No. Three (3) Trustee position. The purpose of said election shall be to elect Trustees to serve for a period of four (4) years from the date of the election, specifically, one Trustee who resides within Trustee Zone No. Two (2) and one Trustee from Trustee Zone No. Three (3).

Upon receipt of the timely filed Declarations, the Board Clerk shall (1) certify the nominees to be placed on the ballot of the political subdivision; and (2) submit the ballot identifying the verified candidates to the Clerk of the County no more than seven (7) days following the deadline to submit the Declaration with the Board Clerk.

Trustee Zone No. Two (2) and Three (3) are more specifically described as follows:

TRUSTEE ZONE NO. TWO (2)

Beginning at the intersection of State Hwy 52 and State Hwy 55, thence Northerly along said State Hwy 55 to Porter Creek Road, thence Easterly along said Porter Creek Road to Pioneer Road, thence Southwesterly along said Pioneer Road to Jackass Creek, thence West along Jackass Creek to the Right Bank (West Bank) of the Payette River, thence Southwesterly meandering along said Payette River to the East-West centerline of the Northwest 1/4 of Section 26, Township 7 North, Range 2 East, Boise Meridian, thence West along said East-West centerline to the Idaho Northern and Pacific Railroad, thence Southerly along said Idaho Northern and Pacific Railroad approximately 0.3 miles to a point approximately 200 feet East of the end of Timberwood Drive, thence West approximately 200 feet to said end of Timberwood Drive, thence West approximately 300 feet along said Timberwood Drive to a point approximately 100 feet South of the end of Shelley Circle, thence North approximately 100 feet to said end of Shelley Circle, thence North along said Shelley Circle to Canyon Street, thence West along said Canyon Street to said State Hwy 55, thence Southwest along said State Hwy 55 to Boise Street, thence West along said Boise Street to the Power Canal, thence Northwesterly along said Power Canal approximately 900 feet to an unnamed creek, thence North along said unnamed creek a short distance to the East-West centerline of Section 27, said Township and Range, thence East along said East-West centerline approximately 1000 feet to a point approximately 700 feet South of the intersection of Stone Lane and said State Hwy 52, thence North

approximately 700 feet to said intersection of Stone Lane and State Hwy 52, thence Easterly along said State Hwy 52 to said State Hwy 55 and the point of beginning.

TRUSTEE ZONE NO. THREE (3)

Beginning at the intersection of the East-West centerline of the Northwest $\frac{1}{4}$ of Section 26, Township 7 North, Range 2 East, Boise Meridian and the Idaho Northern and Pacific Railroad, thence Southerly along said Idaho Northern and Pacific Railroad approximately 0.3 miles to a point approximately 200 feet East of the end of Timberwood Drive, thence West approximately 200 feet to said end of Timberwood Drive, thence West approximately 300 feet along said Timberwood Drive to a point approximately 100 feet South of the end of Shelley Circle, thence North approximately 100 feet to said end of Shelley Circle, thence North along said Shelley Circle to Canyon Street, thence West along said Canyon Street to said State Hwy 55, thence Southwest along said State Hwy 55 to the Right Bank (North Bank) of the Payette River; thence Easterly then Northerly meandering along said Right Bank approximately 1.5 miles to said East-West centerline of the Northwest $\frac{1}{4}$ of Section 26, thence West along said East-West centerline of the Northwest $\frac{1}{4}$ of Section 26 to said Idaho Northern and Pacific Railroad and the point of beginning.

As provided by Idaho Code, Section 34-1407, no write-in vote shall be counted unless a declaration of intent has been filed with the County Clerk indicating that the person desires the office and is legally qualified to assume the duties of school trustee if elected. The person must also provide the signatures of five electors of the candidate's specific zone on a paper nominating petition as provided in section 34-1404, Idaho Code. The declaration of intent shall be filed not later than forty-five (45) days before the day of election.
